




Safeguarding from the fifties till now

- 1950: Shrimpfestival- only three shrimp fishermen on horseback left tourism boomed
- Festival where the shrimp fishers were the ambassadors of Oostduinkerke Attracted new fishermen
- Demonstrating the craft to the tourist during the summer
- Support of the council
- Symbol of the city, of the West Coast
- In 1974: National Fisheries Museum




Safeguarding after nomination

- Increase of heritage tourism more publications and lectures (international)
- Increase of interest of becoming a shrimp fisher on horseback new rules
- Commercial spirit of the new fishermen on horseback (<u>www.paardenvissers.be</u>)
- First female fisher(wo)man

In the museum

- Publication and collaboration with different artiest
- Safeguarding committee:
- _ an expertise and oversight committee.
- _ representatives from different stakeholder communities,
- active collaboration in order to come up with the most suitable measures for safeguarding this element and ensuring its sustainabl
- The NAVIGO-National Fisheries Museum facilitator and organizing the contact between the various actors and associations.
- _ Every stakeholder community has its own role in safeguarding this element and every measure is developed in close collaboration with the fishermen on horseback.
- A new policy regarding becoming a shrimp fisher already 16 households







Safeguarding after the nomination: the future is bright

- Four new, young shrimp fishers our waiting to get started
- Our participatory trajectory: towards a new museumhall
- Creating a new museumhall 'shrimpfishing at the Flemish coast'
 - Collaboration with WIE (Werkplaats Immaterieel Erfgoed Workshop Intangible Heritage)
 - LABO experiment
 - Using different techniques: interviews, questionnaire for visitors, reinterpretation of museumobjects...
